

**MUNICIPALITY OF SKAGWAY NOTICE TO TAXPAYERS FOR FY11**

The 2010 Real Property Tax Bills were mailed June 30<sup>th</sup> and according to Municipal Code Section 4.10.260 **TAXES WILL BE DUE AND PAYABLE BY 5:00 P.M. August 31, 2010, ALL POSTMARKS ARE FINAL. To ensure your return will be postmarked correctly, please have the post office hand cancel, or mail early.** Any payments made after that date will be considered delinquent and a PENALTY OF 20% and INTEREST AT 15% will be added.

PLEASE NOTE that if you receive a property tax bill for property you no longer own, it is because our records indicate that you were either THE LAST OWNER OF RECORD OR THE OWNER OF RECORD ON JANUARY 1st FOR THE PROPERTY AND YOU ARE RESPONSIBLE FOR PAYMENT OF THE TAXES DUE, please notify the Borough Office of the details of the sale or transfer and forward the tax bill on to the current owner to avoid penalty and interest accrued from non-payment of taxes.
